

## Your Guts & Glory Privacy Statement

Your Guts & Glory collects and processes personal data in the execution of its services. This privacy statement is intended to inform you about how we handle your personal data, your associated rights, and other relevant information.

### What personal data does Your Guts & Glory collect?

Various personal data is collected depending on the services rendered. The data we may collect include:

- First and last name;
- Gender;
- Date of birth;
- Place of birth;
- Address details;
- Phone number;
- Email address;
- Information about your health condition;
- Information regarding tests performed and recommendations necessary to provide you with the best possible care and advice;
- Data requested from another healthcare provider to provide the best possible care and advice, with your explicit consent.

### For what purposes does Your Guts & Glory process your personal data?

Your Guts & Glory needs to process data to execute the service agreement. The personal data collected from you are used for the following purposes:

- Communication about training or individual consultations and sending tests.
- The information in your file needed for financial administration.
- Informing other healthcare providers, for example, when coaching is completed or for a referral to another practitioner. This is only done with your explicit consent.
- Anonymous use during peer review or supervision meetings.

### Granting and withdrawing consent

If you give Your Guts & Glory permission to use personal data, you can withdraw this consent at any time.

### Data sharing with third parties

Your data will not be rented, sold, or otherwise shared with third parties. Your data may only be shared with other healthcare providers with your explicit consent.

- You have the right to restrict the processing of your personal data.
- You have the right to object to the processing of your personal data.
- You have the right to data portability.
- You have the right to file a complaint about how Your Guts & Glory handles your data. You can do this by emailing us. You can also file a complaint with the Dutch Data Protection Authority.
